- Analysing repairs and voids activity to inform homes investment needs, to improve the quality of homes and improve the customer experience
- Working with internal & external customers build local knowledge and context into homes management and planned programme production
- Undertaking smoothing and modelling of the planned programme to optimise timing of investment in homes and enable contractor delivery / continuity
- Applying quality standards to the homes portfolio to ensure a consistent standard of home is provided and customers are kept safe
- Creating a dynamic 30-year planned programme for use in financial planning and creating visibility for internal and external customers
- Feeding into and shaping the energy efficiency strategy
- Implementing a data integrity strategy which ensures all data is accurate and pinpointed for collection
